2. **HOW TO ENTER:** Beginning Monday, November 2, 2009 through approximately Friday, November 13, 2009 Participants may listen to the KS1075 Morning Show from approximately 5am to approximately 9am weekdays (Monday through Friday only) for ANY song performed by Rihanna. When the song begins, participants may call 303-228-1075. Once a participant is identified as the 10th Caller, they will automatically receive a copy of Rihanna's new CD "Rated R" and qualifies for the Grand Prize. The Station is the official time keeping entity for the Contest. Time Delay Between Over-the-Air Analog Signal and Other Signal Delivery: Due to the time delay that exists between the Station's analog and digital over-the-air signals and the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station digital or online signal may hear the cue to call later than listeners listening to Station's analog over-the-air signal.
